AN ORDINANCE TO AMEND SEC. 6-4 ENTITLED “REGULATION OF LICENSES” OF CHAPTER VI ALCOHOLIC BEVERAGE CONTROL OF THE GENERAL CODE OF THE BOROUGH OF THE WOODLAND PARK, heretofore introduced, does now pass on first reading, and that said ordinance be further considered for final passage at a meeting to be held on the 11th day of May, 2016, at 7:00 P.M., or as soon thereafter as the matter can be reached, at the regular meeting place of the Municipal Council and that at such time and place all persons interested be given an opportunity to be heard concerning said ordinance, and that the Municipal Clerk is hereby authorized and directed to publish said ordinance according to law with a notice of its introduction and passage on first reading and of the time and place when and where said ordinance will be further considered for final passage.

Resolution R16-142, a resolution authorizing the issuance of General Improvement Refunding Bonds, Dated May 5, 2016, authorized pursuant to the refunding ordinance (16-05) adopted by the Mayor and Council of the Borough on March 16, 2016. Said Bonds are being issued to refund \$7,020,000 aggregate principal amount of the Borough’s outstanding General Improvement Bonds dated July 15, 2009, with an anticipated savings of some \$375,000.
