**AWARD OF CONTRACT
PROVISION AND INSTALLATION OF FENCING AT RECYCLING CENTER**

WHEREAS, the Mayor and Council of the Borough of Woodland Park, County of Passaic, State of New Jersey, desire to award a contract for the provision and installation of fencing at the Woodland Park Recycling Center; and

WHEREAS, a bid document was prepared to solicit bids for this fencing; and

WHEREAS, the bid was designed that an award would be made to the lowest responsive/responsible bidder; and

WHEREAS, this project will be funded by the Borough's 2013 Bond Ordinance; and

WHEREAS, this bid was advertised on February 28, 2014 in the Herald News in compliance with the New Jersey State Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.); and

WHEREAS, on March 12, 2014 at 11:00 a.m., four (4) bids were received as follows:

WHEREAS, the Borough's Administrator has reviewed the specifications of the product offered by National Fence Systems, Inc., and has determined that that product is not equal to or better than the product specified in the bid document and recommends rejection of the bid as not meeting the required specifications; and

WHEREAS, the Borough's Administrator has also reviewed the bid submitted by Absolute Fence Services, Inc., and has determined that this contractor failed to provide with their bid submission a catalog or cut sheets from the proposed manufacturer for the ornamental fencing offered in the bid, which was a requirement, and recommends rejection of the bid as not meeting the required specifications;
