**RESOLUTION AUTHORIZING WEST PATERSON
BOYS AND GIRLS CLUB FOOTBALL PROGRAM
TO HOLD A CARNIVAL AND RAFFLE**

WHEREAS, the Mayor and Council are in receipt of a request from Scott R. Nayda Sr. on behalf of the West Paterson Boys and Girls Club Football Program, requesting permission to hold a Carnival at the West Paterson Boys and Girls Club, 8 Memorial Drive, Woodland Park, New Jersey from Wednesday July 8, 2015 to Saturday, July 11, 2015 from 5:00 P.M. to 9:00 P.M. on Wednesday and Thursday and from 5:00 P.M. to 10:00 P.M. on Friday and from 3:00 P.M. to 10:00 P.M. on Saturday; and

WHEREAS, West Paterson Boys Club Inc., Woodland Park, N.J. 07424, is also seeking approval to conduct an On Premise 50/50 Raffle on said days to be drawn at 9:00 P.M.; and

WHEREAS, the applicant has filed an application with Legalized Games of Chance under the state of New Jersey; Regulations (N.J.A.C.13:47-6.4) as well as the Municipal Clerk’s office of the Borough of Woodland Park; and

WHEREAS, notification for recommendation has been sent to the Woodland Park Fire Department, Department of Public Works and the Police Department, Chief Anthony Galietti and recommendations are as follows:

1. Minimum of 3 Police Officers for security;
2. Memorial drive to be closed on Monday, July 6, 2015 and re-opened on Monday, July 13, 2015 at 7:00 A.M. to allow for set up and break down time;
3. Notification should be made to the residents on Memorial Drive regarding street closure and event information;
4. Use of proper road closing devices; and

NOW, THEREFORE BE IT RESOLVED, that the Mayor and Council of the Borough of Woodland Park, County of Passaic, State of New Jersey does hereby give authorization to the West Paterson Boys Club Inc., to hold a Carnival and one On Premise 50/50 Raffle to be held from Wednesday, July 8, 2015 to Saturday, July 11, 2015 at the West Paterson Boys and Girls Club, 8 Memorial Drive, Woodland Park, New Jersey.
