RESOLUTION R15-191**

**CONTRACT AWARD
2015 ROAD PROGRAM**

WHEREAS, the Mayor and Council of the Borough of Woodland Park, County of Passaic, State of New Jersey desire to have the following streets resurfaced under the 2015 Road Program: Highview Drive; Grandview Drive; Valley Drive; Brookview Drive; and Sunset Drive (Highview to Brookview), and the recycling center located in the Borough of Woodland Park; and

WHEREAS, a bid was released on June 29, 2015, with a return date of July 10, 2015, to secure a contractor to resurface the referenced streets and the recycling center; and

WHEREAS, on July 10, 2015, two (2) bids were received for the referenced work effort as follows:

WHEREAS, funds are available in the 2015 Municipal Bond Ordinance (Item A) to pay for the resurfacing of the streets under the 2015 Road Program; and funds are available in the 2013 Municipal Bond Ordinance (Item C) for the resurfacing of the recycling center;

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Woodland Park, County of Passaic, State of New Jersey hereby award a contract to AJM Contractors, Inc., 300 Kuller Rd., Clifton, NJ for the repaving of the streets under the 2015 Road Program in an amount not to exceed of \$420,551.00; and a contract for the repaving of the recycling center in an amount not to exceed \$74,665.00.

BE IT FURTHER RESOLVED, that Mayor Kazmark is hereby authorized to execute all documents relative to this work effort.
