**CONTRACT AWARD  
POLICE DEPARTMENT DISPATCH SERVICES  
MANAGED SERVICES AGREEMENT**

**WHEREAS**, the Mayor and Council of the Borough of Woodland Park, County of Passaic, State of New Jersey has awarded (R15-190) a contract to Goosetown Communications, 58 North Harrison Avenue, Congers, NY 10920 to reconstruct the dispatch area/console within the Woodland Park Police Department to accommodate new radio dispatch equipment; and

**WHEREAS**, the Mayor and Council now desire to secure the communication equipment to be installed in the to be constructed dispatch console; and

**WHEREAS**, Goosetown Communications has provided a proposal to the Borough whereby Goosetown will design, deploy, maintain and lease an Avtec two position dispatch console system for a period of sixty (60) months at a monthly rate of \$3,263.34 with no purchase option to the Borough under New Jersey State Contract (83892); and

**WHEREAS**, the lease agreement between Goosetown and the Borough shall commence the 1<sup>st</sup> day of January, 2016;

**NOW, THEREFORE, BE IT RESOLVED**, that the Mayor and Council of the Borough of Woodland Park, County of Passaic, State of New Jersey do hereby authorize the Borough to enter into a lease agreement with Goosetown Communications, 58 North Harrison Avenue, Congers, NY 10920, for the leasing of an Avtec two position dispatch console system for a period of sixty (60) months at a monthly rate of \$3,263.34 with no purchase option; and

**BE IT FURTHER RESOLVED**, that this lease agreement between Goosetown and the Borough shall commence the 1<sup>st</sup> day of January, 2016 and is subject to the availability of funds in the 2016 Municipal Budget as well as all subsequent Municipal Budgets for the life of the lease term; and

**BE IT FURTHER RESOLVED**, that the Borough Administrator is hereby authorized to execute all documents relative to this matter.
