**RESOLUTION AUTHORIZING APPROVAL TO SUBMIT  
A GRANT APPLICATION AND EXECUTE A GRANT AGREEMENT

FOR SECTION 3 OF THE MCBRIDE AVENUE STREETScape PROJECT  
FISCAL YEAR 2016**

**WHEREAS**, the New Jersey Department of Transportation makes funds available to municipalities and counties for road improvement projects through the municipal aid portion of the New Jersey Transportation Trust Fund;

**WHEREAS**, the Borough Engineer has recommended that the Borough’s Mayor and Council apply to the New Jersey Department of Transportation for funds that are available under the New Jersey Transportation Trust Fund Authority Act, Fiscal Year 2016 Municipal Aid Program for the purpose of constructing Section 3 of the McBride Avenue Streetscape Project;

**WHEREAS**, the Borough’s Mayor and Council has considered this recommendation;

**NOW, THEREFORE, BE IT RESOLVED** that the Mayor and Council of the Borough of Woodland Park, formally approves the grant application for the above stated project.

**BE IT FURTHER RESOLVED** that the Mayor and Clerk are hereby authorized to submit an electronic grant application identified as MA-2016-McBride Avenue Streetscape Project (Section 3) 00110 to the New Jersey Department of Transportation on behalf of the Borough of Woodland Park.

**BE IT FURTHER RESOLVED** that the Mayor and Clerk are hereby authorized to sign the grant agreement on behalf of the Borough of Woodland Park and that their signature constitutes acceptance of the terms and conditions of the grant agreement and approves the execution of the grant agreement.
