**AWARD OF CONTRACT
CURBSIDE RECYCLING**

WHEREAS, the Mayor and Council of the Borough of Woodland Park, County of Passaic, State of New Jersey desire to award a contract for the collection, transportation and disposal of all recyclable materials collected within the Borough; and

WHEREAS, the current contract with Advanced Recycling, Inc., at a rate of \$14,333.33/month will expire on December 31, 2015; and

WHEREAS, the Mayor and Council advertised a bid (15-04) for the collection, transportation and disposal of curb side collection of recyclable materials, and a bid (15-05) for the collection, transportation and disposal of recyclable materials collected at Westmount Apartments, in compliance with the New Jersey State Local Public Contracts Law (N.J.S.A. 40A:11-1 et. seq.) on October 1, 2015 in The Herald News; and

WHEREAS, on October 16, 2015, one (1) bid was received from Gaeta Recycling and opened by the Borough Administrator;

NOW, THEREFORE BE IT RESOLVED, that the Mayor and Council of the Borough of Woodland Park, in the County of Passaic, State of New Jersey, does hereby award a contract to GETACAN, Inc., DBA Gaeta Recycling, 278-282 West Railway Ave., Paterson, NJ in an amount not to exceed of \$1,372,373.00 (\$22,872.88/month), for a five (5) year contract starting January 1, 2016 and ending on December 31, 2020, for the collection, transportation and disposal of all recyclable materials collected within the Borough including (1) commingled recyclable materials, (2) newspapers and corrugated cardboard, (3) brush, grass clippings and leaves (includes tipping), in compliance with the bid specifications and bid document.
