RESOLUTION R16-117**

**INTERLOCAL SERVICES AGREEMENT BETWEEN THE BOROUGH OF
WOODLAND PARK'S DEPARTMENT OF INSPECTIONS, CODE
ENFORCEMENT AND THE BOROUGH OF GLEN RIDGE.**

WHEREAS, the Borough of Woodland Park desires to authorize a shared Services Agreement between the Borough of Glen Ridge and the Borough of Woodland Park's Department of Inspections, comprised of Woodland Park's Construction Code Official and Sub Code Officials as set forth in Section 17-1.1 of the General Code of the Borough of Woodland Park; and

WHEREAS, Glen Ridge desires to utilize the services of the Woodland Park's Department of Inspections, Construction Code Official and Sub Code Officials to conduct inspections and review plans in connection with the renovations of the Glen Ridge Country Club in the Borough of Glen Ridge; and

WHEREAS, the parties have agreed that the Department of Inspections of the Borough of Woodland Park will provide such services to the Borough of Glen Ridge in accordance with the Uniformed Shared Services and Consolidation Act, N.J.S.A. 40A:65-1, *et. seq.* (the Shared Services Act) to provide the services subject to this Agreement; and

WHEREAS, in consideration for providing such services set forth herein, all permit fees in connection with this Project shall be paid by the Applicant, (the Contractor or the Glen Ridge Country Club), directly to the Borough of Woodland Park; and

NOW THEREFORE BE IT RESOLVED, that the Mayor and Council of the Borough of Woodland Park, County of Passaic, State of New Jersey, do hereby authorize the Mayor and the Municipal Clerk to execute the Interlocal Services Agreement on behalf of the Borough with the Borough of Glen Ridge, to utilize the services of the Woodland Park's Department of Inspections, comprised of Woodland Park's Construction Code Official and Subcode Officials to conduct inspections and review plans in connection with the renovations of the Glen Ridge Country Club in the Borough of Glen Ridge and that this agreement shall commence upon this date and shall continue until the project is completed.
