## Woodland Park Summer Kids Club Program FAQs

- Will my child need to wear a mask throughout the day?
  - Upon entering and exiting the park, masks **MUST** be worn. Once campers have checked in with their counselor and are in their designated group, masks will be optional depending upon the preference of the camper. Their groups will remain the same throughout the course of the 4-week program.
  - Groups are to remain separate. In times where groups will cross paths/have direct interaction, masks must be worn. When children leave their groups, i.e. changing locations/using the bathroom, masks also must be worn.
- Will staff members be required to wear a mask?
  - To ensure the safety of our campers as well as the entirety of the staff, staff will wear face coverings. Staff will additionally undergo daily health screenings prior to the opening of our program each morning.
  - Counselor mask wearing will be pending weather temperatures of extreme heat.
- What is the size of each group of campers?
  - Campers will be in groups of up to 20 with 2 counselors per group. Each group will remain with the same staff member and campers for the entire 4-week program.

- Groups of 20 campers will remain separate. In times where social distancing between groups cannot be maintained, masks **MUST** be worn.
- What are the sanitization procedures?
  - Bathrooms are TOUCLESS, complete with touchless flush and automatic faucets. Hand sanitizing stations will be set up underneath the pavilions and throughout the park. All facilities and equipment will be sanitized multiple times throughout the course of the day.
  - Children will additionally be provided with a bag on the first day with personal hand sanitizer, crayons, markers, and mask. Hand sanitizing stations will be set up throughout Zaccaria Park for the use of our campers and staff.
- What if the CDC/NJ Department of Health guidelines change?
  - As the guidelines change frequently, we will continue to update parents on our most recent policies. We will adhere to guidelines as they change.

### **Additional Guidelines**

- If a parent must enter the park, a mask needs to be worn. We do not encourage parents to enter and instead ask that you call the camp phone, 973-278-5053 from the top of the hill.
- Temperatures of campers will be taken daily. Prior to exiting their vehicles in the AM, a staff member will take their temperature through the window. If the temperature is above 100.4° F, the camper will not be permitted to attend camp that day.
- Snack time will be staggered and children will eat with their group members only. The snack stand will NOT be open. We ask you to pack a snack for your child. The water fountain will be CLOSED and no child will be able to access it. We ask that your child be provided with enough water for them to remain hydrated throughout the day.
- The Spray Park will be open for campers to use. There will be time slots where each group will be able to access this amenity. If your camper would like to use the Spray Park, we ask that the child be sent to camp wearing their bathing suit. You can provide a pair of clothes that the child can put back on after they are done.
- Please sunscreen your child before dropping them off. They should be independent in doing this task for themselves.
- In the event of a full rain-out, Kids Club will be CLOSED. You will be notified via e-mail on the status of the program once the decision is made. In the event of a small rain shower while at camp, groups may need to combine for proper coverage, in which case your child will wear their mask.
- If your child becomes ill at home, the program **MUST** be notified.
